Fifty-one years ago today, history was made when the U.S. Supreme Court's *Roe v. Wade* ruling legalized abortion across our country.

But you know what happened in 2022. In *Dobbs v. Jackson Women's Health Organization*, six justices on the U.S. Supreme Court – who've shown again and again that they do not support freedom, equality, and autonomy for all people – overturned *Roe*. That ruling made it clear we can't count on the federal courts' protections for our fundamental rights to abortion and reproductive care, transgender anti-discrimination, and marriage equality.
