At the ACLU of Oregon, we remember and honor George Floyd, and the many Black people harmed and killed by police violence, by fighting to rollback the police state and mass incarceration. Please join us in this work with these actions:

- **Oppose SB 238A – Warrantless Drone Bill:** Senate Bill 238A would expand police and sheriffs' ability to use drones to spy on everyday people, without court oversight. This type of unchecked police power is especially dangerous as fascism grows in power across our country. Law enforcement could use drones to spy on protestors, abortion clinics, immigrants and refugees, and more. [Please continue to tell lawmakers: No drone surveillance without court oversight!](#)
- **Tell Portland City Hall to Fund Our Parks:** Portland Mayor Wilson [proposed cutting the budget for parks by \\$7 million while increasing Portland](#)

police funding by \$1.9 million. Please note: The first link will take you to a third-party website, opb.org. Councilors Avalos and Morillo successfully led an effort to change this, getting the \$1.9 million back to Portland parks. Please tell the Mayor and City Council that well-maintained parks make Portland safer and more liveable. **Find your Portland electeds' contact info on the City of Portland website.**
